The University of San Diego Transfer Credit Policy

Courses from accredited institutions are generally transferable if the grades are C or better. **Online courses** and courses from non-accredited institutions or trade schools do not transfer. All courses transferred to USD are transferred for unit credit only and are not calculated into the GPA.

The University of Southern California Non-Traditional Course Formats

Foreign language or laboratory science courses taught online or via distance learning, television, or correspondence will not earn course equivalence and will not satisfy Core requirements; they earn elective units only. USC will review on a case-by-case basis courses taught in non-traditional time modes such as concentrated "intensive" sessions or special weekend modules. Petitions regarding these types of classes are accepted from USC students only.

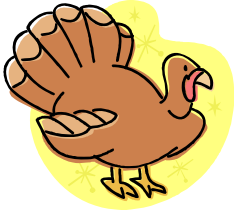

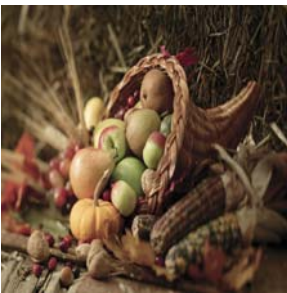
